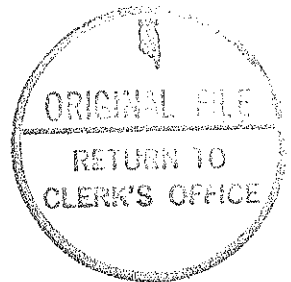


IN THE SUPREME COURT OF THE STATE OF KANSAS

Re: Garnishment



Administrative Order No. 11

*Rescinded 4-18-90 by
Admin Order No. 76*

Clerks of the district courts are hereby directed to amend the dollar amounts in the instructions to the garnishee in the garnishee's answer form appearing at K.S.A. 1978 Supp. 60-718(b) and in Form No. 8a in the appendix of forms following K.S.A. 61-2605 as follows:

For Calendar Year 1979

- I. If the defendant-employee's disposable earnings are less than
- \$ 87.00 for a weekly pay period
 - \$174.00 for a bi-weekly pay period
 - \$188.50 for a semi-monthly pay period
 - \$377.00 for a monthly pay period

pay the employee as if his or her paycheck were not garnisheed.

- II. If the defendant-employee's disposable earnings are
- \$ 87.00 to \$116.00 for a weekly pay period, pay him or her \$87.00;
 - \$174.00 to \$232.00 for a bi-weekly pay period, pay him or her \$174.00;
 - \$188.50 to \$251.33 for a semi-monthly pay period, pay him or her \$188.50;
 - \$377.00 to \$502.67 for a monthly pay period, pay him or her \$377.00.

- III. If the defendant-employee's disposable earnings are more than
- \$116.00 for a weekly pay period, pay him or her 75% of his or her disposable earnings;
 - \$232.00 for a bi-weekly pay period, pay him or her 75% of his or her disposable earnings;
 - \$251.33 for a semi-monthly pay period, pay him or her 75% of his or her disposable earnings;
 - \$502.67 for a monthly pay period, pay him or her 75% of his or her disposable earnings.

For Calendar Year 1980

- I. If the defendant-employee's disposable earnings are less than

\$ 93.00 for a weekly pay period
\$186.00 for a bi-weekly pay period
\$201.50 for a semi-monthly pay period
\$403.00 for a monthly pay period

pay the employee as if his or her paycheck were not garnisheed.

- II. If the defendant-employee's disposable earnings are

\$ 93.00 to \$124.00 for a weekly pay period, pay him or her \$93.00;
\$186.00 to \$248.00 for a bi-weekly pay period, pay him or her \$186.00;
\$201.50 to \$268.67 for a semi-monthly pay period, pay him or her \$201.50;
\$403.00 to \$537.33 for a monthly pay period, pay him or her \$403.00.

- III. If the defendant-employee's disposable earnings are more than

\$124.00 for a weekly pay period, pay him or her 75% of his or her disposable earnings;
\$248.00 for a bi-weekly pay period, pay him or her 75% of his or her disposable earnings;
\$268.67 for a semi-monthly pay period, pay him or her 75% of his or her disposable earnings;
\$537.33 for a monthly pay period, pay him or her 75% of his or her disposable earnings.

For Calendar Year 1981

- I. If the defendant-employee's disposable earnings are less than

\$100.50 for a weekly pay period
\$201.00 for a bi-weekly pay period
\$217.75 for a semi-monthly pay period
\$435.50 for a monthly pay period

pay the employee as if his or her paycheck were not garnisheed.

- II. If the defendant-employee's disposable earnings are

\$100.50 to \$134.00 for a weekly pay period, pay him or her \$100.50;
\$201.00 to \$268.00 for a bi-weekly pay period, pay him or her \$201.00
\$217.75 to \$290.33 for a semi-monthly pay period, pay him or her \$217.75;
\$435.50 to \$580.67 for a monthly pay period, pay him or her \$435.50.

III. If the defendant-employee's disposable earnings are more than


\$134.00 for a weekly pay period, pay him or her 75% of his or her disposable earnings;

\$268.00 for a bi-weekly pay period, pay him or her 75% of his or her disposable earnings;

\$290.33 for a semi-monthly pay period, pay him or her 75% of his or her disposable earnings;

\$580.67 for a monthly pay period, pay him or her 75% of his or her disposable earnings.
