Re: Kansas Judicial Branch Fiscal Year 2020 through and including Fiscal Year 2025 Surcharge and Application to Reinstatement Fees Assessed by Municipal Courts

Rescinding 2017 SC 65

Pursuant to the authority granted in 2019 Senate Bill 20, a Judicial Branch Surcharge is assessed in accordance with the attached schedule, effective July 1, 2019, which also continues in effect the \$22.00 Judicial Branch Surcharge to be assessed by municipal courts on drivers' license reinstatement payments collected.

The following terms and conditions apply:

- 1. The district, municipal, and appellate courts may waive all or part of the Judicial Branch Surcharge set forth in this order on motion of the party to be charged, and upon a showing that such surcharge will result in undue hardship to the petitioning party;
- 2. Notwithstanding the provisions of Supreme Court Administrative Order No. 41 or local rules pertaining to the order of payment in criminal cases, funds received in criminal cases must first be applied to the Judicial Branch Surcharge in the amount required, then must be credited to other charges or entities as Supreme Court Administrative Order No. 41 or local rule directs;
- 3. In criminal and civil cases in which a party is ordered to pay court costs, the Judicial Branch Surcharge is considered a portion of such court costs;
- 4. The Judicial Branch Surcharge is not a service or operations charge and funds will be utilized solely to reduce the deficit in the budget; and
- 5. This order is effective on and after July 1, 2019, and will continue until June 30, 2025, unless rescinded or amended by the Kansas Supreme Court.
 - 6. On the effective date of this order, 2017 SC 65 is hereby rescinded.
